Cheryl Kruger motioned to create divisions within the All State Art Competition to make it a more equitable competition; Kathleen Sweet seconded. The motion passed unanimously.

Emerging Excellence: It's not finalized where the sites are going to be yet, but it looks like there will be 3 events across the state.

Youth Art Month Day went well in March. Christy and her committee did a great job again.

There was discussion about if the Traveling Show can continue. Jeanna Gerot would like to step down from this position.

Morgan Singleton motioned to retire the Traveling Show; Melissa Nelson seconded & the motion passed unanimously.

Mentoring/Iowa Alliance for the Arts: Leon Keuhner-

The Fine Arts Summit will be Thurs. June 20. This is the 1st time IAAE, Iowa Arts Council & the Dept. of Ed. have come together to present information about the Fine Arts Standards in Iowa. In the Every Student Succeeds Act (ESSA) there is funding given for well rounded education. As we know, the visual arts are a big part of a well rounded education! These new federal funds, called Title IV, Part A or Student Support and Academic Enrichment Grants (SSAEG), come through the Dept. of Ed. to local school districts.

Leon also told us that the Mentor grant funding was approved. In addition, The Hinterland Music Festival will be the weekend of Aug. 3-4 in St. Charles, IA. There will be a booth to raise money for IAAE again. Please

consider donating necklaces, earrings, bracelets or other Art items for this. Liz Bloomberg will collect any items by Aug. 1 and bring them to the festival.

There will be an Iowa Arts Advocacy Caucus Day on Aug. 15. Pre-registration will be in early July. It will be a free event at Hoyt Sherman Place. This event will inform participants about how to ask candidates what their position is on Arts Education. There will also be information from each candidate on how they will support the Arts Education if elected. The event will be about 3 hours long. Watch your email for more information.

Leon wrapped up his comments by informing us that as he talks to our legislators, many of them ask about STEAM Education. Legislators want to support STEAM Education more than STEM, according to the questions and comments that Leon has heard.
